The extraordinary general meeting of the Company has been held on 14 January 2019 to approve the share consolidation which became effective on 15 January 2019.

As a result of the share consolidation:-

(1) the authorised share capital of the Company shall become HK\$100,000,000 divided into 1,000,000,000 consolidated shares of par value of HK\$0.10 each, of which 582,955,860 consolidated shares will be in issue.

(2) the number of consolidated shares to be allotted and issued under the share option scheme of the Company adopted on 18 May 2011 and the exercise price of share options adjusted to 95,940 shares and HK\$1.626 per share.

(3) the number of consolidated shares to be allotted and issued under the share option scheme of the Company adopted on 18 May 2011 and the exercise price of share options adjusted to 48,575,000 shares and HK\$ 0.726 per share.
