The extraordinary general meeting of the Company has been held on 17 August 2020 to approve, among other, the share consolidation which became effective on 19 August 2020.

As a result of the share consolidation:-

(1) the authorised share capital of the Company shall become HK\$100,000,000 divided into 500,000,000 consolidated shares of par value of HK\$0.20 each, of which 291,477,930 consolidated shares will be in issue

(2) the number of consolidated shares to be allotted and issued under the share option scheme of the Company adopted on 18 May 2011 and the exercise price of share options adjusted to 16,605 shares and HK\$3.252 per share.

(3) the number of consolidated shares to be allotted and issued under the share option scheme of the Company adopted on 18 May 2011 and the exercise price of share options adjusted to 26,232,750 shares and HK\$0.558 per share.

(4) the number of consolidated shares to be allotted and issued under the share option scheme of the Company adopted on 18 May 2011 and the exercise price of share options adjusted to 29,147,500 shares and HK\$0.228 per share.
