A copy of the order confirming the Capital Reduction and the Share sub-division and the minutes approved by the Court containing the particulars required under the Companies Law with respect to the Capital Reduction were filed and duly registered with the Registrar of Companies in the Cayman Islands on 18 November 2020 (Cayman Islands time).

The capital reduction and share sub-division became effective before 9:00 a.m. on Thursday, 19 November 2020 resulting in the increase of the number of authorised shares of the Company.

The authorised share capital of the Company became HK\$100,000,000 divided into 5,000,000,000 new shares of par value of HK\$0.02 each.
